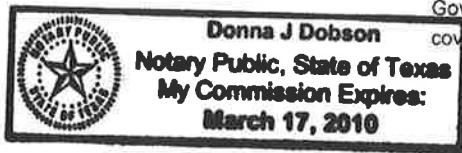

The Board of Trustees meeting was called to order by Mr. Jones at 6:00 p.m. The invocation was presented by Mr. Jones.

MINUTES

On a motion by Dr. Howard, seconded by Mr. Wilkerson, and by unanimous vote, the Minutes of the Regular Meeting of October 22, 2007 were approved as presented.

DISBURSEMENTS

On a motion by Mr. Thompson, seconded by Mr. Niemeier, and by unanimous vote, the disbursements for October 2007 were approved as presented.

OPPORTUNITY FOR CITIZENS TO ADDRESS THE BOARD

There were no citizen requests to address the Board.

OLD BUSINESS

Under Consideration of a Site and Funding Proposal from the Community of Taylor for Development of the East Williamson County Higher Education Center (EWCHEC) Dr. John Nelson, Director, Taylor Economic Development Corporation, presented a proposal

relationship between the Texas Book Company and Temple College has been excellent. The book store is experiencing steady growth and is renovating and enlarging the existing store. The company has agreed to contribute \$40,000 to our renovation of the Arnold Student Center. Upon approval of this addendum the current contract will be extended to October 31, 2016.

On a motion by Mr. Thompson, seconded by Mr. Niemeier, and by unanimous vote the Three-Year Extension of the Contract with Texas Book Company was approved.

Under Consideration of a Recommendation to Accept a Proposal for Campus Food Service—Café/Vending/Catering Dr. Nigliazzo reported that a modern food court will be a part of the renovated Arnold Student Center. Two proposals were received and the review committee recommends that an agreement be extended to 2TheTop, LLC, owned by Mr. Greg Rhoads. The food court will include Schlotzsky's, Maggie Moo's, and Austin City Java. Selection criteria and grading on the two bidding vendors was included in the Board packet.

On a motion by Mr. Niemeier, seconded by Dr. Howard, and by unanimous vote the Proposal for Campus Food Service- Café/Vending/Catering was approved. Mr. Jones and Mr. Thompson abstained from voting due to their relationship with the proposed candidate.

Under Consideration of the Purchase of Two Mobile Modular Buildings, Including Approval of an Interlocal Agreement with the Region VIII Education Service Center for Cooperative Purchasing Services Mr. Criswell brought forth quotes for purchasing two mobile modular buildings from Mobile Modular Management Corporation. The purchase price of a four office modular is \$65,396.20. The purchase price of classroom space is \$68,201.63. The buildings will be located directly behind ISC next to Berry Hall. More space is required due to continuous enrollment growth and ongoing construction projects. This is an unbudgeted item and funding will be provided through increase revenue.

On a motion by Mr. Thompson, seconded by Mr. Wilkerson, and by unanimous vote the purchase of two mobile modular buildings, including approval of an Interlocal Agreement with the Region VIII Education Service Center for Cooperative Purchasing Services was approved.

Under Consideration of the Purchase of Computers for the English Writing Lab and CAD Lab on the Main Campus Mr. Criswell made a recommendation to purchase 20 Dell Precision Workstations at a cost of \$56,944.20 and 30 Dell Optiplex Workstations at a cost of \$22,094.10. The CAD and English Departments requested these replacements for their respective existing labs. These items are budgeted with an additional \$30,000 of expenditure to be budgeted from excess revenue in the remaining year.

On a motion by Mr. Niemeier, seconded by Ms. Morales, and by unanimous vote the Purchase of Computers for the English Writing Lab ad CAD Lab on the Main campus was approved.

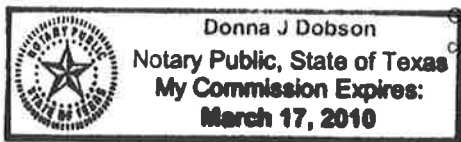

On a motion by Ms. Morales, seconded by Mr. Wilkerson, and by unanimous vote, the Minutes of the Regular Meeting of February 18, 2008 and the Special Called Meeting of March 10, 2008 were approved as presented.

DISBURSEMENTS

On a motion by Mr. Thompson, seconded by Mr. Wilkerson, and by unanimous vote, the disbursements for February 2008 were approved as presented.

OPPORTUNITY FOR CITIZENS TO ADDRESS THE BOARD

There were no citizen requests to address the Board.

OLD BUSINESS

There was no old business for discussion or consideration.

BID PURCHASE ITEMS

Under **Consideration of Bids for the Campus Alert System** Mr. Criswell recommended the selection of In-House Security Systems, Inc. of Temple, TX as the vendor for the purchase of equipment and installation of the campus alert system. Four bids were received and In-House Security Systems, Inc. provided the lowest bid of \$92,500.00. The company will be able to provide the required as well as desired services for the college. Mr. Criswell gave an overview of the equipment and services included in the bid. It is a good system which allows for expansion, connectivity of building door locks, and can be integrated with the video surveillance. If approved by the Board installation could begin immediately with the system operational by early summer.

On a motion by Ms. Morales, seconded by Dr. Dyck, and by unanimous vote the Board, with one vote abstention by Mr. Jones due to client conflict of interest, approved the selection of In-House Security Systems, Inc. as the vendor for the purchase of the campus alert system at a cost of \$92,500.00.

Under **Ratification of the Purchase of a 2008 Chevrolet Pickup** Mr. Criswell reported the pickup was purchased through a State contract which ended April 4, 2008. It was necessary to place the order before the deadline in order to receive delivery of the truck during the 2007-2008 calendar year. He requested that the Board ratify the purchase of the pickup at a cost of \$25,924.10.

On a motion by Mr. Thompson, seconded by Dr. Dyck, and by unanimous vote the Board ratified the purchase of a 2008 Chevrolet Pickup.

MISCELLANEOUS

Mr. Randy Baca recognized Mr. Miguel Benavides and Ms. Lesley Keeling-Olson, two doctoral candidates from the University of Mary Hardin-Baylor, who attended the Board meeting as observers. Also attending as an observer was Mr. Gabriel Escarciga from the Leadership Temple program.
