Functions and Purpose:

To plan and implement the recommended and approved activities related to commencement exercises.

Associate Director of Admissions and Records, Co-Chair

Administrative Assistant to the VP of Educational Services

Director of Student Life

Faculty and Staff appointed by the Chair

Two students to be appointed by the Student Government

The Committee meets on-call by the Chair.

CURRICULUM COMMITTEE

Functions and Purpose:

The Curriculum Committee shall have the responsibility to review, evaluate, and approve faculty recommended revisions to the College Curriculum. The Committee is responsible for ensuring the College curriculum is directly related and appropriate to the purpose of the College and the diplomas, certificates or degrees awarded; to the ability and preparation of the students admitted; and to the financial and instructional resources of the College.

DISTANCE EDUCATION ADVISORY COMMITTEE

FUNCTIONS AND PURPOSE:

The Distance Education Advisory Committee has the responsibility to discuss distance education programs, evaluate, review, and update distance education policies and guidelines that are consistent with the College's purpose, Texas Higher Education Coordinating Board and SACS requirements. The Committee shall report to the Curriculum Committee concerning all new courses to be delivered via DE to insure the DE courses are of the same quality as place-based courses.

Six Faculty Members Teaching Via Distance Education--Three appointed by the Faculty Council President, three appointed by the Vice President of Educational Services

The Committee meets on date agreed to by the Committee members or on-call by the chair.

EMPLOYEE BENEFITS COMMITTEE

Functions and purpose:

The Employee Benefits Committee is responsible for reviewing and recommending fringe benefit programs, policies, and procedures for College employees.

Composition:

Associate Vice President, Resource Management, Chair
One member of the Professional Staff selected by the President's Council
Two Faculty Members selected by the Faculty Council
Two members of the Classified Staff selected by the Classified Staff Committee

The Committee meets on-call by the chair.

FACULTY ADVANCEMENT COMMITTEE

Functions and Purpose:

The Committee will make recommendations for disbursement of Temple College Funds for the professional advancement of the faculty. Such activities may include in-service training, workshops, seminars, speakers, and other educational opportunities.

Composition:

Four faculty members elected by the Faculty Council
One faculty member appointed by the incoming Faculty Council President.
