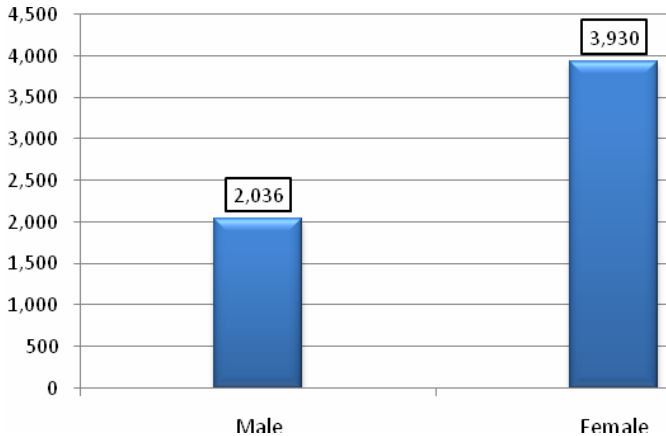

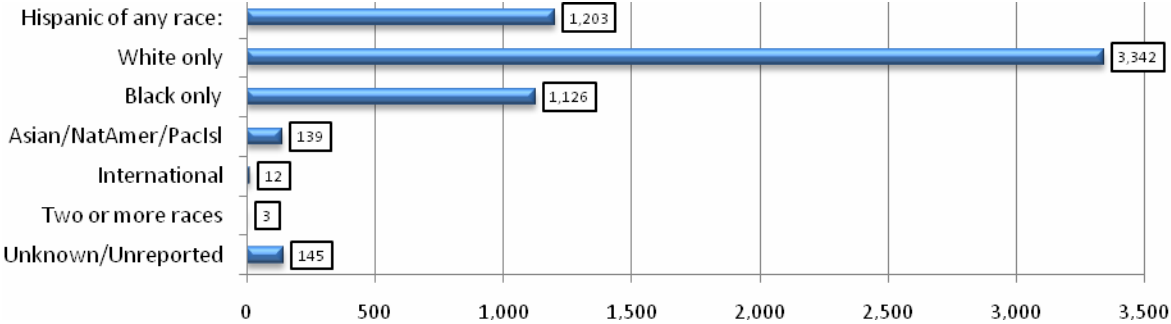

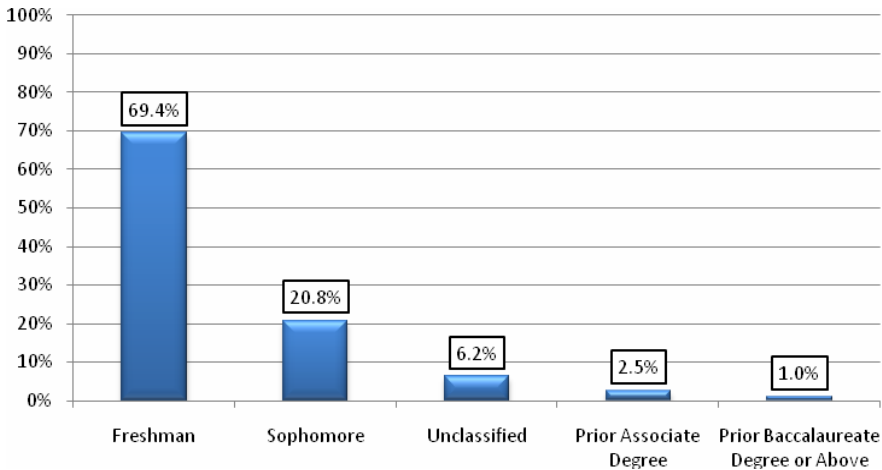

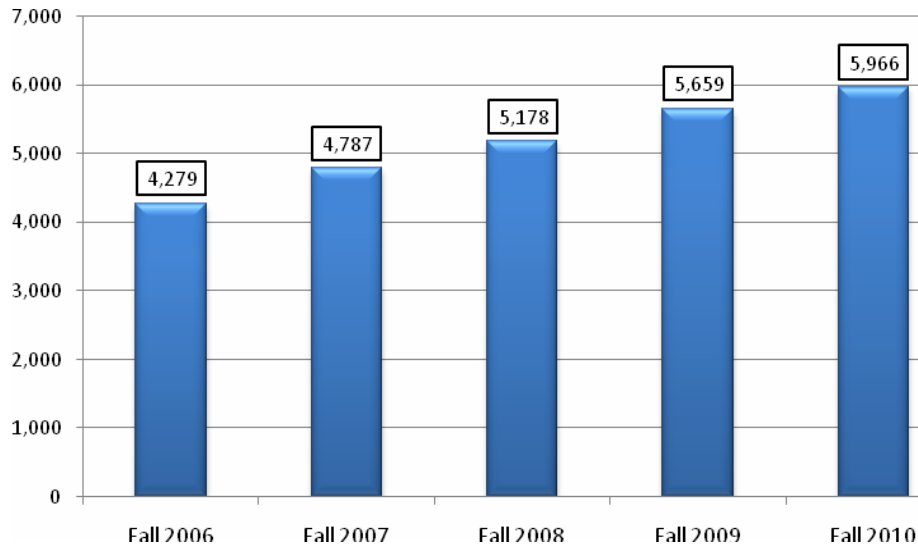

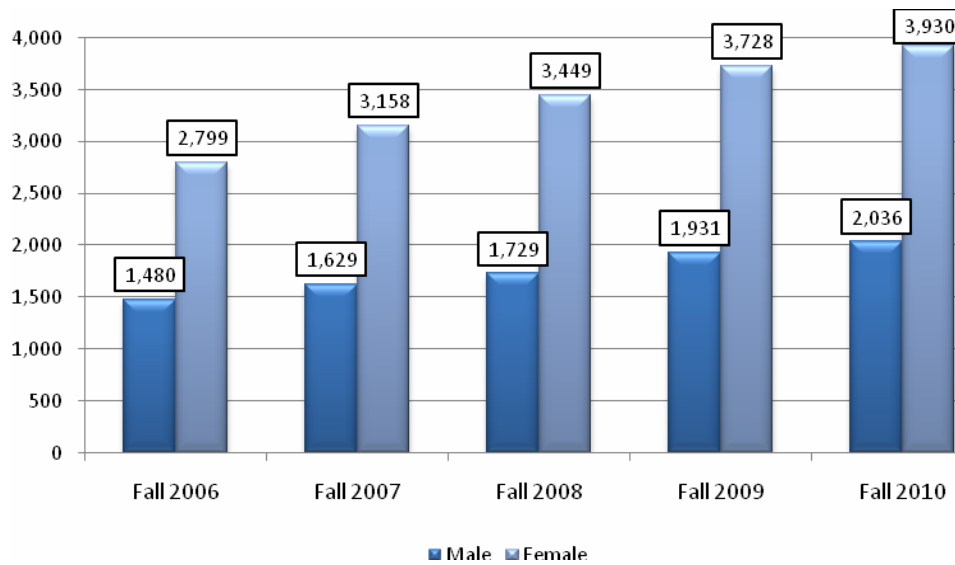

Unduplicated Headcount

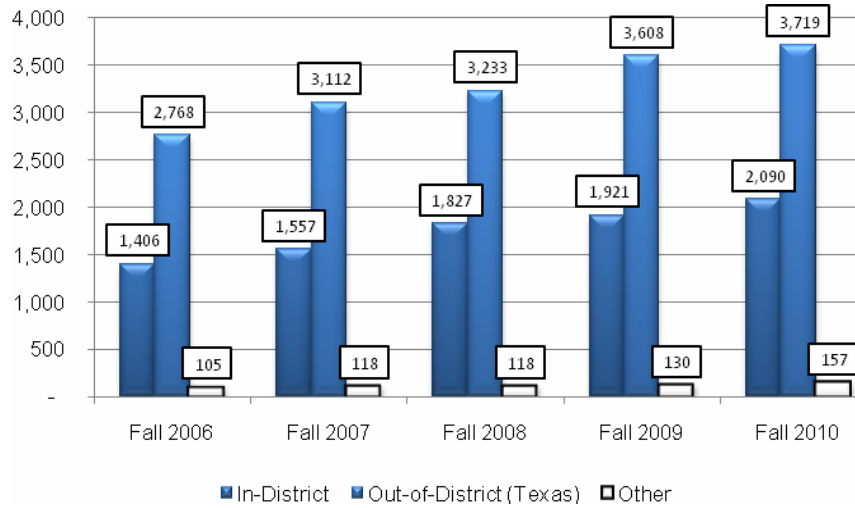


Enrollment by Gender

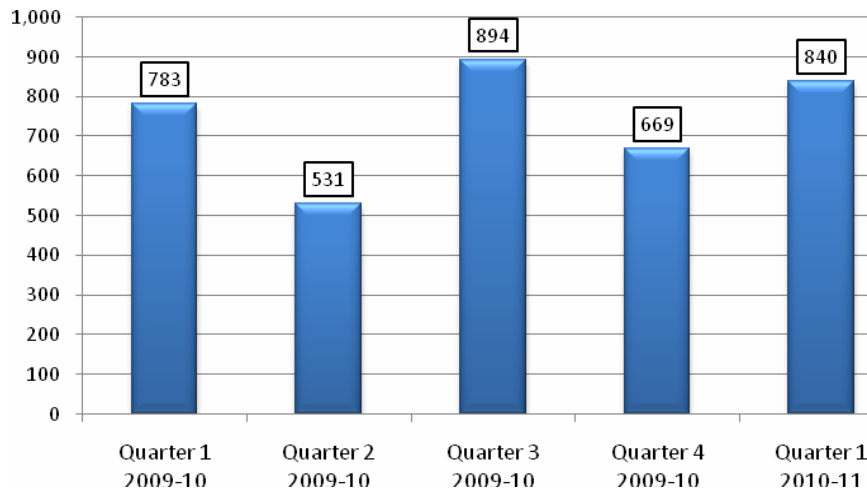

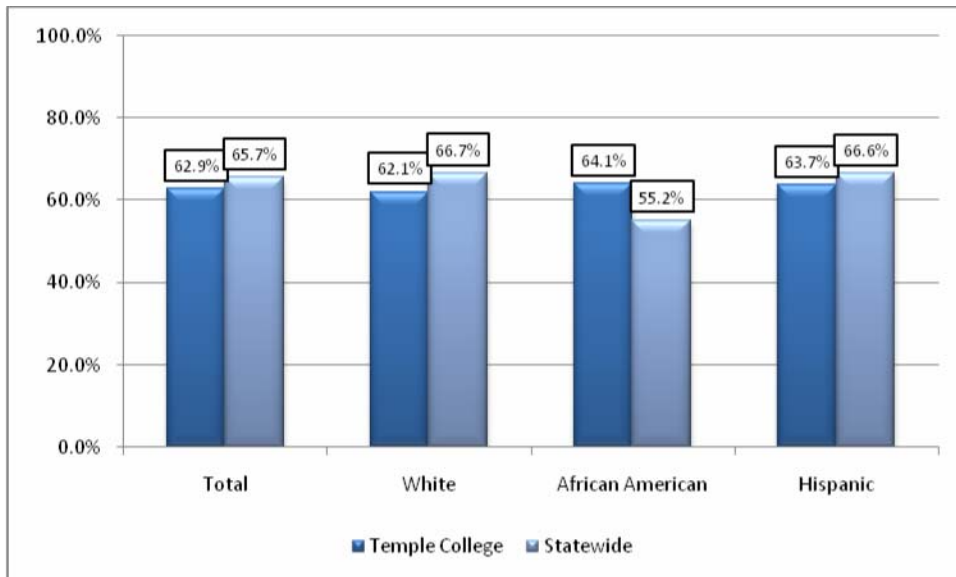

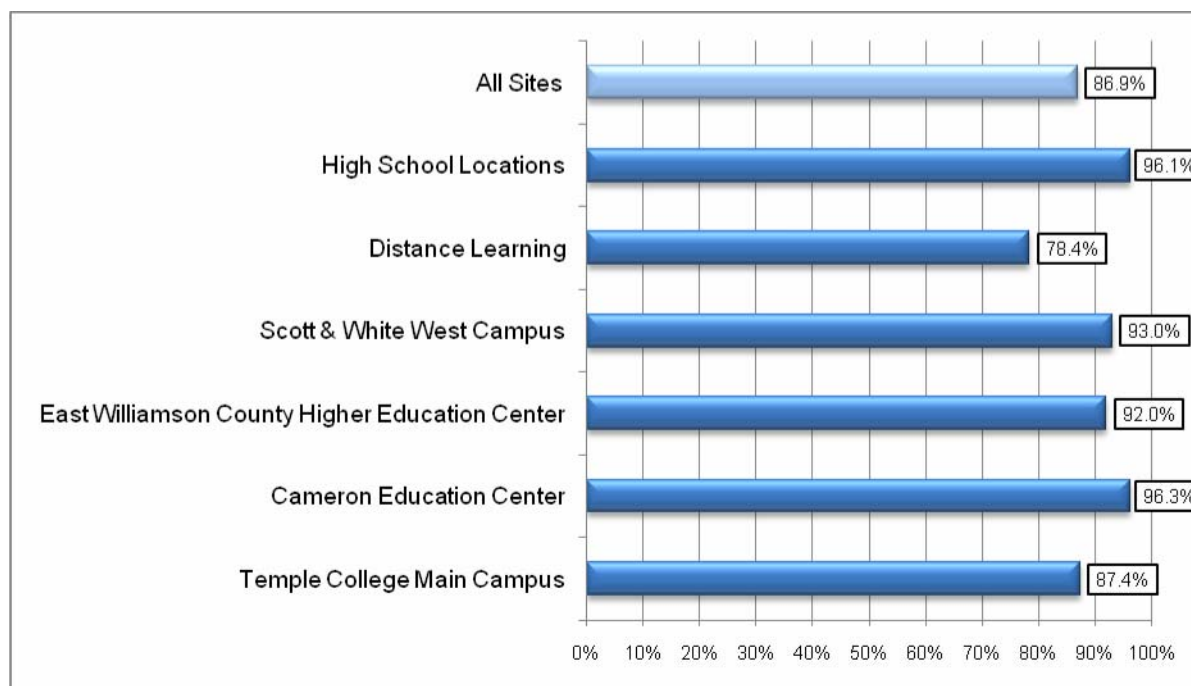

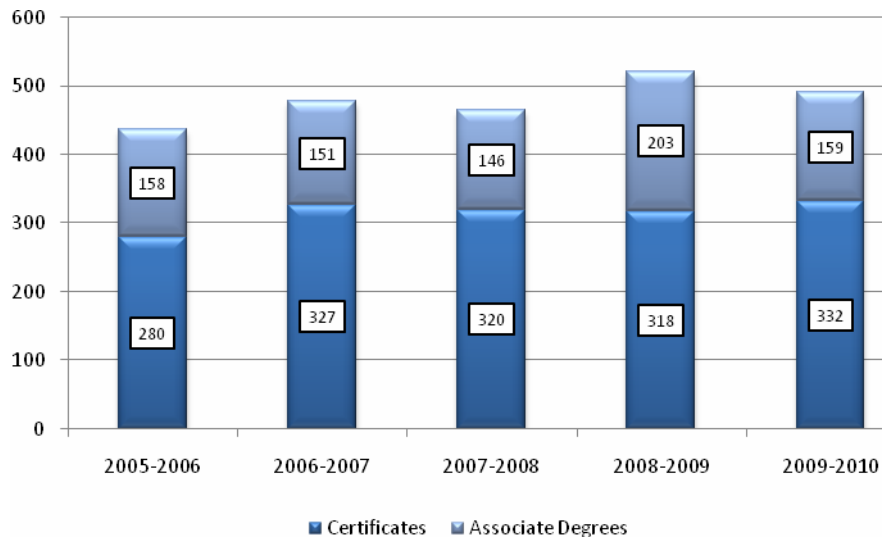

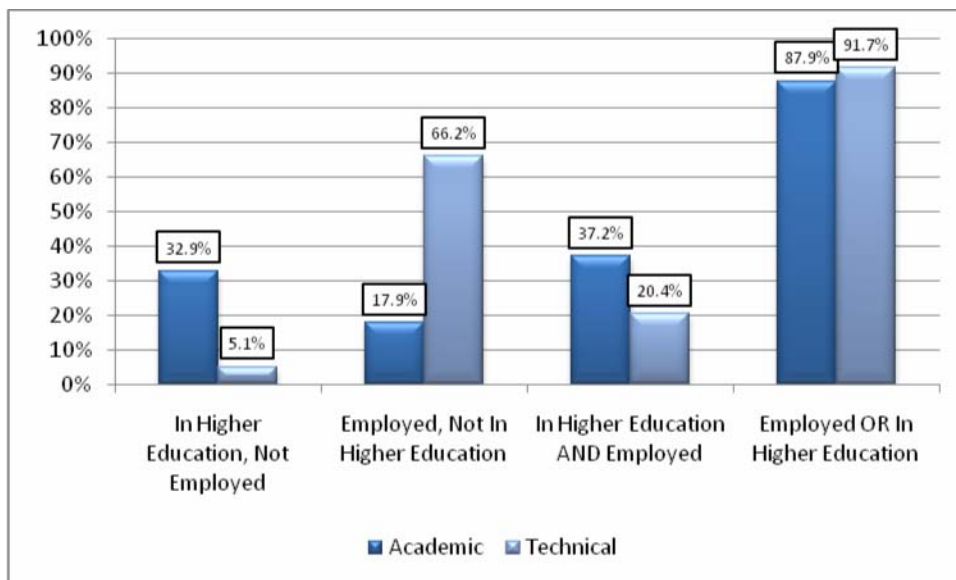

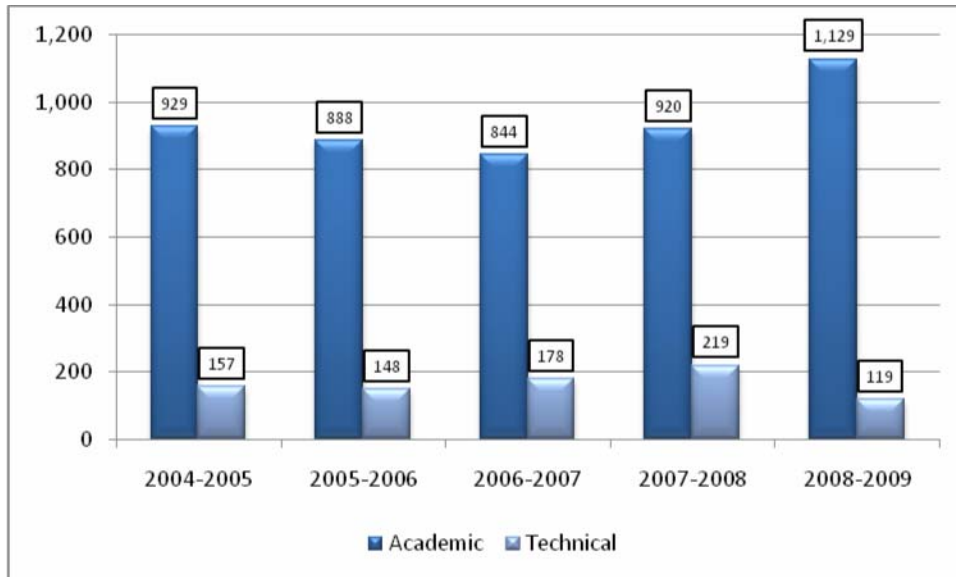

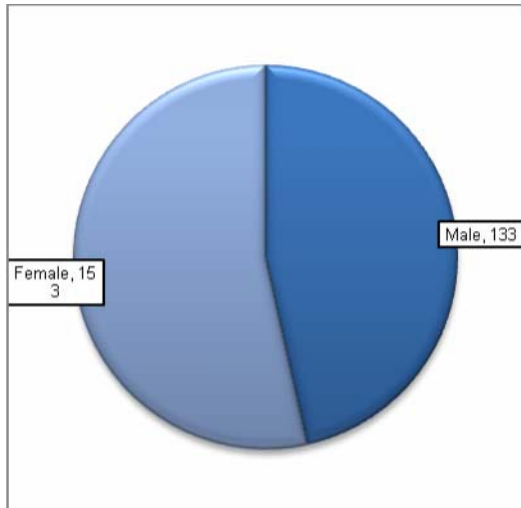

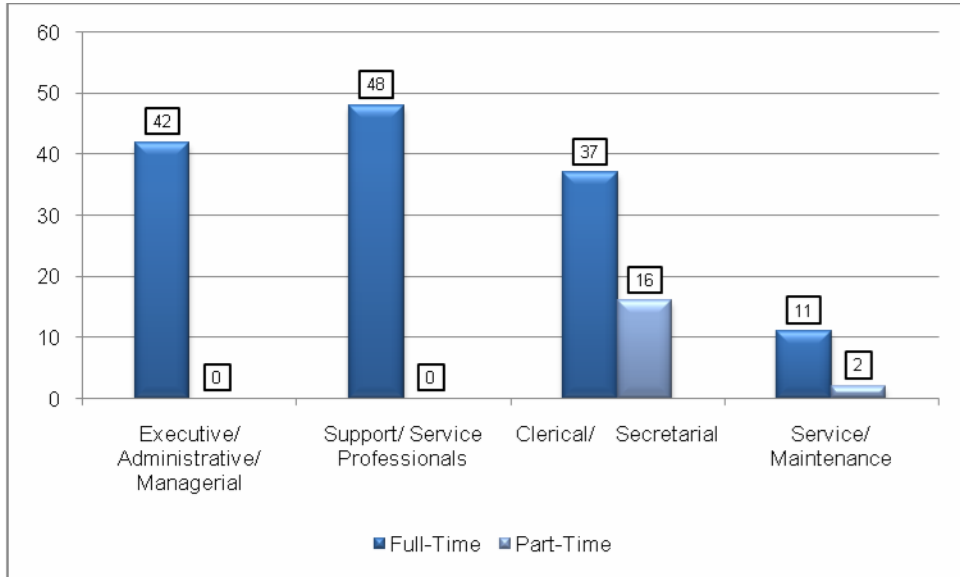
